Youth Programs







STRIVE & WIOA

The STRIVE and WIOA (Workforce Innovation & Opportunity Act) Youth Programs are rooted in hands on training that instills self-sufficiency skills for justice-involved youth. Each youth receives work readiness training and job placement. Participants are able to see the range of careers available to them, develop concrete skills and receive industry recognized credentials. Case managers help address the core issues that led to justice-involvement. After completion, staff continue to work individually with youth to further educational and career advancement.

In 2018, the programs had 239 participants, 32 obtained permanent employment and 37 received industry-recognized certifications. Six recived paid internships and 17 participants recidivated.



Training Builds Success

The Youth Garden Program had 104 participants who also had 100% improvement in 2018.

Youth Garden

The Youth Garden is a six-week job training program which provides a supportive, structured environment to prepare youth (14-21) for personal, professional and academic success. Through paid transitional employment, youth receive job readiness preparation, learn positive communication skills and engage in leadership training. Program components include healthy cooking classes, environmental education and youth development workshops.

Success Grows

Youthful Offender Rehabilitation Program (YORP) implements evidence-based curricula, cognitive behavioral therapy and interventions. YORP counselors address topics to encourage positive permanent behavior change. During this 480-day program at the county-operated Youthful Offender Units in the East Mesa and Kearny Mesa Juvenile Detention Facilities, each young person is assigned a dedicated counselor who oversees their individual case plan. Upon release, counselors work to ensure successful transition into the community.



In 2018, the program served 119 participants, 39 obtained permanent employment and of those, 21 were still with that employer six months later. Twelve participants recidivated.



Adult Programs

JRJ

Job Readiness Training (JRT) is an intensive four-week program which helps formerly incarcerated adults secure and retain meaningful, livable-wage employment. During the course of this program, participants gain confidence, learn basic job-readiness skills and receive assistance to overcome barriers to employment.



In 2018, the program had 203 participants, 131 graduates and 118 obtained employment.



Lessons in Success




Reentry Court helps individuals who have been released from custody, have violated their terms of community supervision and have a history of substance abuse and co-occurring disorders. This 18-36 month court-supervised program provides comprehensive treatment and case management for non-violent justice-involved San Diegans. Second Chance, in collaboration with the UC San Diego Department of Psychiatry, provides outpatient alcohol and drug treatment, case management, mental health counseling and drug testing services.



In 2018, the program had 53 new enrollees.

Reentry Works provides comprehensive career center services at the East Mesa and Las Colinas Detention and Reentry Facilities. In partnership with the County of San Diego Sheriff and Probation, the program helps ensure successful reentry into the workforce and the community.




- 135 men enrolled
- 65 received individualized case management & work readiness workshops in custody
- **59** received services after being released, & only 2 recidivated (4%)

Sober Living Housing

Second Chance operates five sober living homes across San Diego County which offer a safe, supervised, and substance-free environment with case management essential to recovery. Sober living promotes personal responsibility, restores self-esteem and eliminates isolation by creating a community atmosphere – all with the ultimate goal of maintaining sobriety and transitioning to independent living. These homes provide the jump-start to a new life that people desperately need.

Rosie's Story

Rosie lost her job, her home, her freedom and her family to addiction.

Since her release from incarceration a year ago, Rosie has poured her heart into her recovery and works tirelessly to complete the steps needed to regain custody of her children.

Rosie's road to recovery began with counseling through Second Chance's Reentry Court Program where she addressed the issues driving her past substance abuse. Since graduating from the Job Readiness Training program, Rosie maintains two jobs and is working on earning her high school diploma. She says the days are long but she focuses on what is most important – her children. Rosie is motivated each time she attends a dance recital or helps her daughters with their homework.

Although they live with their grandparents, Rosie sees her children daily. She currently lives in Second Chance Sober-Living and recently applied for an apartment and for the first time in her life, she has a budget, a plan, and most importantly hope.


Sobriety. Housing. Education. Employment. All of these elements are essentials to Rosie's selfsufficiency. Rosie adds that it was also the encouraging environment that helped her regain her confidence and stability. At 32, Rosie has regrets, but she is grateful for the opportunity she has been given for a second chance.




