# **Program Summary**

The Collaborative Court Program will serve non-violent adult offenders (age 18+) who are high risk and high need with histories of drug use and criminal justice contacts, previous treatment failures, co-occurring mental illness, and high rates of health and social problems. The goal of our Collaborative Court Program is to equip clients with the tools and resources necessary to be alcohol and drug free, to successfully manage their co-occurring mental illness, and to comply with the laws and avoid committing new criminal offenses.

To be successful, you'll have to be a loyal and dedicated critical thinker; a creative problem solver who doesn't shy away from challenges and takes pride in everything you do. You believe anything worth doing is worth doing right, every single time. If you don't know the answer, you'll dig to find it. You love people. You enjoy leading others. You value diversity and embrace change.

The SUD Counselor, Certified reports to the Senior Program Manager of the Collaborative Court Program. This role is responsible for providing wrap around case management support to Collaborative Court Program clients including in-custody assessments, case noting, goal setting, reentry planning, progress monitoring, social service navigation, and group facilitation. The SUD Counselor, Certified must

be able to work collaboratively as part of a team including treatment staff, law enforcement, and court representatives. This position is responsible for a wide range of activities to include but are not limited to:

- Maintain a caseload of Collaborative Court Clients.
- Complete in-custody assessments of new referrals in collaboration with treatment partners.
- Attend weekly court team meetings, followed by court sessions, to share progress updates and/or current treatment barriers experienced by clients on caseload.
- Facilitate evening group sessions including Relapse Prevention and Moral Reconciliation Therapy amongst others.
- Develop Treatment Plans with clients and maintain case notes, according to County and Drug Medi-Cal standards and timeframes.
- Provide transportation for clients as needed and assist with scheduling and accompanying participants to appointments.
- Assist with BAC and urinalysis testing; Requires direct observation of reproductive organs of those being tested.
- Connect and refer clients to resources within the community that support their treatment process.
- Participates in Second Chance staff meetings, trainings and other duties assigned by program manager and/or program director.
- Other duties as assigned.

## What skills do you need?

This is challenging work. A positive "can do" spirit is a must. For this specific role, you'll also need:

- Organized and ability to manage time and priorities.
- Collaborative team player with the ability to build strong relationships.
- Compassionate with the ability to be sensitive to cultural differences or behavior in a multicultural community and various cultural and ethnic groups in a tactful, professional, and effective manner.
- Excellent interpersonal communication, listening, counseling and facilitation skills.
- Solution focused with the ability to identify and resolve problems in a timely manner.
- Ability to work with a high degree of autonomy and exercise responsible judgment.
- Must be able to speak, read, and write in English. Bilingual in English and Spanish languages preferred.
- Must be computer literate (proficient in Microsoft Word, Excel, Outlook, and Data Management Systems.

#### Qualifications

- Two or more years of case management or drug and alcohol treatment-related experience.
- Experience working with at-risk, and justice involved youth and adults. Lived Experience strongly preferred.
- Experience updating and managing participant data in a data management system.
- Required to have a valid driver's license and properly registered and insured motor vehicle meeting the minimum level of insurance as defined under the California DMV Code.
- Meet background and security clearance guidelines for facility access and passes background check.

#### Education

- Bachelor's degree in Social Work, Counseling, Criminal Justice, Community Development, or related field, or equivalent of 5 years demonstrated experience.
- Must have a current SUD certification.
